Prior to founding Centaurus Energy, he held various positions within Enron's Wholesale Division, including Head of Natural Gas Derivatives. In May 2012, John announced his retirement from Centaurus Energy to concentrate on philanthropic activities.

Mr. Arnold serves on the boards of Breakthrough Energy Ventures, an investor-led venture capital firm dedicated to funding transformational technologies that will reduce global greenhouse gas emissions; Civica, Inc., a nonprofit generic pharmaceutical company; and The City Fund, a nonprofit dedicated to supporting new governance models in K-12 education. He holds a B.A. from Vanderbilt University and lives in Houston, Texas with his wife and three children.

Ric Campo has been Camden's Chief Executive Officer since its initial public offering in 1993. Under Ric's leadership, Camden has grown from a Texas-based real estate firm with assets valued at \$200 million in 1993 to an industry leader with a national footprint and assets valued at more than \$20 billion.

After working for a private Houston real estate company, Ric co-founded Camden's predecessor companies in 1982 with Keith Oden and has spent 40 years (and counting) building a successful organization known for management proficiency, development, construction capabilities and technology, training, and marketing savvy.

Ric currently serves as Chairman of the Port Commission of the Port of Houston Authority, as well as on the Board of Directors of several organizations that focus on Houston's economic development and quality of life. The organizations include Central Houston, Inc., Greater Houston Partnership, Baker Ripley and The Coalition for the Homeless. He is the past chairman of the Super Bowl LI host committee and Houston First Corporation.

Ric is also a member of the National Association of Real Estate Investment Trusts and has served on the Executive Board and Advisory Board. He served on the Executive Committee and was past chair of the National Multifamily Housing Council. Ric is a member of the American Institute of Certified Public Accountants and graduated from Oregon State University.

WHITNEY WOLFE HERD

Whitney Wolfe Herd is the Founder and CEO of Bumble Inc., the parent company that operates Badoo, Fruitz, and Bumble, three of the world's fastest growing dating apps worldwide.

In 2014, Wolfe Herd launched Bumble to challenge the antiquated rules of dating and create a space where people could find healthy and equitable relationships. Bumble is the only dating app where women make the first move. The company launched Bumble BFF in 2016 for friendship finding and launched Bumble Bizz for professional networking in 2017. In January 2020, Wolfe Herd welcomed Blackstone as Bumble's new majority owner with a shared vision of growth for Badoo and Bumble. In 2021, Wolfe Herd led Bumble's IPO as the youngest woman CEO to ever take a company public.

Wolfe Herd has previously been named to TIME Magazine's 100 Most Influential People, the Forbes "30 Under 30" list, the Bloomberg 50, and InStyle's 50 Women Who Are Changing the World. She has been featured on the cover of Fast Company, Forbes, and WIRED magazines, and in 2021, Bumble was named as one of Apple's Apps of the Year.

Currently, Wolfe Herd serves on the Board of Directors of Imagine Entertainment as well as the Executive Board at her alma mater, Southern Methodist University's Dedman College of Humanities and Sciences.

THOMAS O. HICKS

Thomas O. Hicks is Chairman, Founder and Partner of Hicks Holdings LLC, a family office that owns and manages real estate, corporate assets, and investments, including a private equity firm, Hicks Equity Partners.

Previously, Mr. Hicks was Co-Founder and Chairman of Hicks, Muse, Tate & Furst, Inc., a prominent private equity firm, and a former Owner and Chairman of the Dallas Stars, a National Hockey League club, and the Texas Rangers, a Major League baseball club. Under Mr. Hicks' ownership, the Stars won the Stanley Cup in 1999 and the Rangers made it to The World Series in 2010.

A graduate of the University of Texas at Austin, he served on the Board of Regents, and was instrumental in forming, and getting legislation approved, to establish UTIMCO, the University of Texas' Investment Management Company that manages in excess of \$40 Billion. Mr. Hicks was UTIMCO's first Chairman.

Mr. Hicks and his wife, Cinda, reside in Dallas. They have 6 children and 11 grandchildren.

Jeffery D. Hildebrand is the Executive Chairman and Founder of Hilcorp Energy Company, the largest, privately-held, independent exploration and production company in America and the largest operator and gas supplier in Alaska. He is also the Executive Chairman and Founder of Harvest Midstream Company, a leading, privately-held midstream services provider, and JDH Capital, a private investment firm. All three companies are headquartered in Houston.

Mr. Hildebrand earned a Master of Science in petroleum engineering in 1985, and a Bachelor of Science in geology in 1981, both from the University of Texas at Austin, where he was a member of Pi Epsilon Tau, Petroleum Engineering's Honor Society.

Mr. Hildebrand is a member of the All American Wildcatters, the National Petroleum Council, the Engineering Advisory Board at the University of Texas at Austin, the Independent Petroleum Association of America, the American Association of Petroleum Geologists, the Society of Petroleum Engineers, the Houston Geological Society, the Texas Board of Professional Geoscientists, the Texas Independent Petroleum Royalty Owners Association, the Management Council of the King Ranch Institute for Ranch Management, and the Louisiana Independent Oil and Gas Association.

Active in his community, Mr. Hildebrand currently serves on the Boards of Central Houston, Inc., the Houston Livestock Show and Rodeo, the Houston Police Foundation, and Rice University's Baker Institute for Public Policy. Most recently, he was appointed to the Texas Parks and Wildlife Commission.

Mr. Hildebrand was recognized as the 2005 Distinguished Engineering Graduate and the 2013 Distinguished Petroleum & Geosystems Engineering Alumnus from The University of Texas at Austin. He received the TXOGA Distinguished Service Award, the 2021 Kay Bailey Hutchinson Center Lifetime Achievement Award, and was named South Texan of the Year, 2022 by Texas A&M University's Kleberg Institute.

The Greg Armstrong Future Texas Legend Veteran Award

The Douglas L. Foshee Future Texas Legend Veteran Award

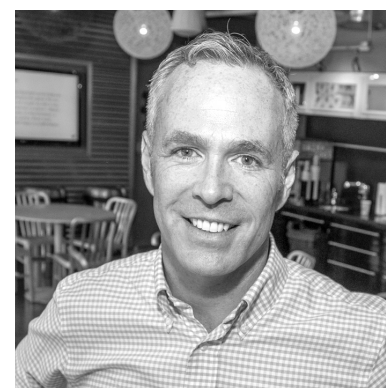

Courtney has always followed her desire to serve and make the world a better place. She is the Co-Founder and CEO of EarthViews, Inc., which is a conservation-minded internet technology company that creates virtual 360° imagery maps and surveys of aquatic environments and terrestrial habitats. EarthViews is currently focusing on pre-work site assessments for dredging and marine work and is also in the process of establishing a non-profit entity. His goal is to become a serial entrepreneur and pursue more ventures that will positively impact society.

Future Texas Business Legend Award

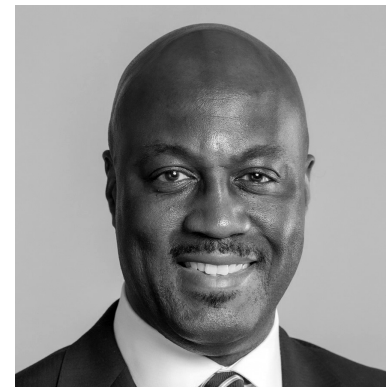

The Robert H. Dedman Award

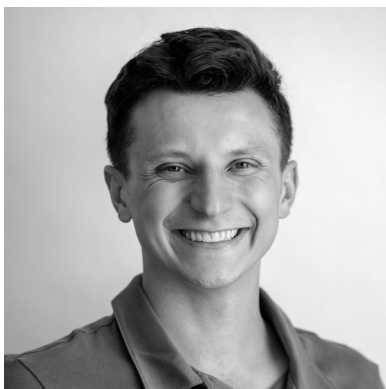
