The Chair, President, Secretary, all Vice Presidents and the three most recent past Chairpersons and such other At-Large Directors as may be appointed by the Chair serve on the Executive Committee of the TBHFF. The Chair or his/her designated representative presides at all Executive Committee meetings. The Executive Committee oversees the day-to-day operation of the TBHFF, assists the Executive Director in the performance of his/her duties, and exercises all powers and authority of the Board except as expressly

limited. The Chair may call a meeting of the Executive Committee at any time upon reasonable notice, and the business to be transacted at or the purpose of a regular or special meeting of the Executive Committee is not required to be specified in the notice or waiver of notice of the meeting.

Whenever a director has a potential conflict of interest with the TBHFF, he/she must disclose such conflict to the Board of Directors.

After identifying the issue, matter or transaction with respect to which a conflict exists, the director with the potential conflict shall withdraw from any further involvement in that issue, matter or transaction unless a majority of the disinterested directors determine that the conflict is (i) immaterial or not adverse to the interests of the TBHFF, or (ii) the benefits of allowing the person with the conflict to participate in the discussion/consideration, but not the final decision, outweigh the dangers; in which case the person may participate in the discussion, study or consideration of the issue but not the final discussion or decision.
