The Executive Committee oversees the day-to-day operation of the TBHFF, assists the Executive Director in the performance of his/her duties, and exercises all powers and authority of the Board except as expressly limited. The Chair may call a meeting of the Executive Committee at any time upon reasonable notice, and the business to be transacted at or the purpose of a regular or special meeting of the Executive Committee is not required to be specified in the notice or waiver of notice of the meeting.

The Nominating Committee makes an annual report to the Executive Committee and the Board on the status of the membership on the Board including recommendations for election, re-election or dismissal, and on the performance of each Board member with regard to his or her responsibilities as a Director.
